Project Overview

The Unified Board of Supervisors for Greeley County seeks funding from the U.S. Department of Transportation for funding available through the Airport Infrastructure Grant (AIG) program for their Construct Helipad - Phase 2 Construction project which includes constructing a dedicated airport helipad to support medical air transport, improve operational safety, and enhance aircraft movement efficiency at Tribune Municipal Airport.

This opportunity is a formula IIJA program with a local match requirement of 5% of the total project cost. The entity is requesting \$11,447.50 from the Build Kansas Fund, and is providing a local cash match of \$602.50. This request has the potential to unlock \$228,932.00 in federal funds, for a total project cost of \$240,982.00.

The deadline for this opportunity is September 30, 2026, and this Build Kansas Fund application was received on July 1, 2026.
